In addition, Trisura offers several optional extensions of coverage including human rights complaint coverage, offensive declaratory judgement actions coverage (provides funding for proactive legal actions), governmental claims coverage (coverage for claims brought by the Canadian Radio-television and Telecommunications Commission), and a contextual errors and omissions carveback on the bodily injury and property damage exclusion.
